TRANSPORTATION

- 1. You will enforce reasonable travel speed in accordance with state and local laws in all motor vehicles.
- 2. If by motor vehicle:
 - (a.) Driver Qualifications: All drivers must have a valid driver’s license and be at least 18 years of age. **Youth Member Exception:** When traveling to an area, regional, or national Boy Scout activity or any Explorer event under the leadership of an adult (21+) tour leader, a youth member at least 16 years of age may be a driver, subject to the following conditions: (1) Six months’ driving experience as a licensed driver (time on a learner’s permit or equivalent is not to be counted); (2) no record of accidents or moving violations; (3) parental permission has been granted to leader, driver, and riders; (4) a 21 year-old licensed driver must be a passenger in the vehicle.

(b.) If the vehicle to be used as a designed to carry more than fifteen persons (including driver) the driver must have a commercial driver’s license, (CDL).

(c.) Driving time is limited to a maximum of 12 hours and must be interrupted by frequent rest, food, and recreation stops.

(d.) Seat belts are provided, and must be used by ALL passengers and driver. Exception; A school or commercial bus.

(e.) Passengers will ride only in the cab if trucks are used.

OUR PLEDGE OF PERFORMANCE

- 1. We will use the Safe Swim Defense in any water activity.
- 2. We will use trucks only for transporting equipment-no passengers except in the cab. All passenger cars, station wagons, recreational vehicles, and cabs of trucks will have a seat belt for each passenger.
- 3. We agree to enforce reasonable travel speed (in accordance with national state, and local laws) and use only vehicles that are in safe mechanical condition.
- 4. We will be certain that fires are attended at all times.
- 5. We will at all times be a credit to the Boy Scouts of America and will not tolerate rowdy or un-Scout like conduct, keeping a constant check on all members of our group.
- 6. We will maintain high standards of personal cleanliness and orderliness and will operate a clean and sanitary camp, leaving it in a better condition than we found it.
- 7. We will not litter or bury and trash, garbage, or tin cans. All rubbish that cannot be burned will be placed in a tote-litter bag and taken to the nearest recognized trash disposal or all the way home, if necessary.
- 8. We will not deface trees, restrooms, or other objects with initials or writing.

- 9. We will respect the property of others and will not trespass.
- 10. We will not cut standing trees or shrubs.
- 11. We will collect only souvenirs that are gifts to us or that we purchase.
- 12. We will pay our own way and not expect concessions or entertainment from any individual or group.
- 13. We will observe the courtesy to write thank-you notes to persons who assisted us on our trip.
- 14. We will, in case of backcountry expedition, read and abide by the Wilderness Use Policy of the BSA.
- 15. We will notify, in case of serious trouble, the Campmaster and/or Camp Ranger.
- 16. If more than on vehicle is used to transport our group, we will establish rendezvous points at the start of each day and not attempt to have drivers closely follow the group vehicle in front of them.

I hereby certify;

- a. that all drivers meet National BSA requirements and hold a valid (state) drivers license.
- b. that all vehicles used on this outing meet the laws of the state they are registered in and are currently inspected.
- c. that all vehicles are covered with public liability and property damage insurance that complies with the laws of the state in which it is registered and that it equals or exceeds \$50,000/\$100,000 public liability and \$50,000 property damage for passenger cars, station wagons and trucks or \$100,000 property damage and \$100,000/\$500,000 public liability for vehicles carrying ten (10) or more persons.

Cradle of Liberty Council Camp Regulations

- 1. All units in camp must be accompanied by at least two registered leaders (one must be at least 21 years of age or older; the second must be at least 18 years of age.)
- 2. Out of Council units ***must*** bring a validated Local tour Permit.
- 3. All units must check in and out with the Campmasters.
- 4. Units are to arrive in camp with a written roster and program. Please provide a copy for the Campmasters.
- 5. Leaders leaving camp must sign out with the Campmasters.
- 6. Each unit is asked to provide a time to complete a one hour Conservation project.
- 7. Chain saws are **not** permitted in camp.
- 8. No firearms or fireworks are permitted in camp. (only camp rifles, shotguns and ammo may be used.)
- 9. No personal bows, arrows, sling shots, BB guns, etc. are permitted in camp.
- 10. **No drugs are allowed in camp.** prescription medication should be used under the direction of the camp leader.
- 11. **Alcoholic beverages of any kind are prohibited in camp.**
- 12. Snowmobiles, mini-bikes or motorcycles are **NOT PERMITTED IN CAMP.**
- 13. No pets are permitted in camp.
- 14. All camp reservations must be made **AT LEAST TWO WEEKS IN ADANCE** OF THE UNITS ARRIVAL IN CAMP. No Phone reservations will be accepted. All fees must accompany this application.
- 15. **NO REFUNDS or CHANGE OF DATES WILL BE MADE IF A UNIT FAILS TO SHOW UP ON THE RESERVED DATE.** A change of date or refund will only be granted if the unit puts the request in writing to the camping office at least 30 days before arrival date.
